

## Free Living Competition Terms and Conditions

- 1. The Competition: There terms and conditions relate to the competition being run by TenTel Limited to win a year's free rent or mortgage up to the value of £750 per month (the "Competition").
- 2. Qualifying Persons: The Competition is open to persons aged 18 and over and resident in the United Kingdom who are named on a residential lease or private dwelling mortgage except employees of the Promoter or members of their immediate family, agents or any other person who is connected with the creation or administration of the Competition.
- 3. Legal Undertaking: By entering the Competition the entrant ("Entrant") will be deemed to have read and understood these rules and be bound by them and by any other requirements set out in any related promotional material. The Competition is governed by Scottish Law and any matters relating to the Competition will be resolved under Scottish Law and the Courts of Scotland shall have exclusive jurisdiction. The Promoter will not be held responsible for any Entrant entering the Competition unlawfully.
- 4. Competition Entry: To enter the Competition you must purchase one of the Promoter's advance bundles; either Unlimited Advance, Basic Advance or Student Advance prior to the Closing Date. If you meet the Qualifying Persons criteria listed above you will be automatically entered into the Competition when you purchase an advance bundle prior to the Closing Date. Any Entrant who cancels their contract with the Promoter within the statutory 14 day cooling off period will have their entry removed from the Competition. The Promoter reserves the right to refuse or cancel an entry for any reason before the close of the Competition.
- 5. Competition End: The Competition will be open for entries until the later of 31 October 2014 and the date at which 1,000 entries have been received (the "Closing Date"). The Promoter reserves the right to either close or extend the Competition at any time.
- 6. Competition Judgement: The winner of the Competition (the "Winner") will be chosen at random from all of the Entrants after the

Closing Date. The Promoter will attempt to contact the Winner using the telephone numbers and email address provided at the time of entry and held securely in our database. If for any reason we are unable to contact the Winner within 7 days (which may be extended at the sole discretion of the Promoter) of the end of the Competition, the Winner will forfeit the prize and a new winner will be chosen at random. For the avoidance of doubt once the prize has been forfeited the original Winner will have no further claims against the Promoter.

It is the responsibility of the Entrant to ensure and check that the contact details provided to us and held securely in our database are correct and up to date, and the Promoter will not be liable for any losses arising as a result of incorrect details being held in its database, however so arising.

All Entrants are automatically entered onto the Promoter's database for the purpose of conveying information as to the status of the Competition, as well as for any future promotions or Competitions offered by the Promoter.

- 7. Winner's Details: The Winner will be required to send a copy of their passport to the Promoter to confirm their identity and age before any prize will be delivered. The Winner will also be required to provide a certified copy of their mortgage agreement or their lease (whichever is applicable). The Winner will also be required to provide photographs and or pose for photographs and video use in future marketing and public relations by the Promoter. Following receipt and verification of the details requested above by the Promoter, the Winner will be contact in order to make arrangements for delivery of the prize.
- 8. The Prize: The prize is the payment of the Winner's mortgage or rent for one calendar year ("the Prize"). The Prize will be paid in 12 monthly instalments. The Prize is limited to a maximum of £750 per calendar month. In the event that the Winner's mortgage or rent is in excess of £750 per calendar month, only £750 per month will be paid to the Winner. In the event that the Winner's mortgage or rent is less than £750 per calendar month, only a payment to the value of the Winner's mortgage or rent will be paid to the Winner per month.



- 9. Limits of Liability: The Promoter shall not be liable for any loss suffered or sustained to person or property including, but not limited to, consequential (including economic) loss by reason of any act or omission by the Promoter, or its servants or agents, in connection with the arrangement for supply, or the supply, of any goods by any person to the Winner and, where applicable, to any persons accompanying the Winner.
- 10. Electronic Communications: No responsibility will be accepted for failed, partial or garbled computer transmissions, for any computer, telephone, cable, network, electronic or internet hardware or software malfunctions, failures, connections, availability, for the acts or omissions of any service provider, internet, accessibility or availability or for traffic congestion or unauthorised human act.

The Promoter shall use its best endeavours to award the Prize for the Competition to the correct Entrant. If due to reasons of hardware, software or other computer related failure, or due to human error the Prize is awarded incorrectly, the Promoter reserves the right to reclaim the Prize and award it to the correct Entrant, at its sole discretion and without admission of liability. The Promoter shall not be liable for any economic or other consequential loss suffered or sustained to any persons to whom an award has been incorrectly made, and no compensation shall be due.
